A DAY IN THE LIFE OF A LICENSED PSYCHIATRIST

As a licensed psychiatrist/psychiatrist practitioner, you have a critical role within our organization. You are responsible for providing psychiatric services directly to the clients in the program. This position is responsible for maintaining the appropriate records and medical files as per state, federal and agency regulations. This includes ensuring that established procedures are followed and clinical standards that are set for the delivery of psychiatric services are met. Collaboration and coordination with both internal and external resources are crucial to successful client outcomes.

In support of their recovery, you also are responsible for psychiatric coordination which establishes a framework of action to enable the client to achieve specified goals. You will collaborate with medical staff, counselors, clients and significant others, and ongoing evaluation of medication, treatment progress and client needs.

You will complete psychiatric assessments, provide written reports on a timely basis, and provide follow-up visits where appropriate. You will prescribe psychotropic medications, where
